Nancy Rauch Douzinas, PhD, is President of the Rauch Foundation, a New York City-based family foundation focused on regional challenges on Long Island and in Maryland. Since 1990, when she assumed leadership of the Foundation, Nancy has overseen more than \$60 million in grants and charitable activities and leveraged the Foundation's support for even broader impact.

Nancy is a prominent voice for the role of philanthropy in raising awareness of regional needs, sound planning, and informed public discussion of policy priorities. One of the Foundation's best-known initiatives is the Long Island Index, which for 15 years provided unbiased, reliable data for businesses, nonprofits, civic organizations, educators, and townships. Thanks to research coming out of the Index, the Foundation played an important role in advancing one of the region's largest infrastructure projects in recent years: the Third Track project on the Long Island Rail Road.

Core to the Foundation's work has been its commitment to Long Island's children – their early well-being and future opportunities. The Foundation has long supported programs that promote quality early childhood education

and advance research and thought leadership in the field. In the area of the environment, the Foundation has helped to preserve land and water quality on Long Island and in Maryland.

Apart from the Foundation, Nancy provides further civic leadership by serving on the boards of the Stony Brook University Foundation, Columbia University's Teachers College, Accelerate Long Island, Greentree Foundation, and North Shore Land Alliance.

Prior to devoting herself to the Rauch Foundation, Nancy had a 20-year career as a psychologist and family therapist. A lifelong resident of the Greater New York City area, she graduated from Smith College and received a master's degree and doctorate from New York University in community psychology. She and her husband reside in Lloyd Harbor and have two married daughters and five grandchildren.

For decades, the Long Island community has been strengthened and supported by the Knapp Family. Through many avenues of involvement, this family has had a tremendous impact on countless people through their philanthropy. We are very grateful that impact has involved the YMCA of Long Island.

The Knapp and Swezey Family's impact goes back more than 100 years, beginning with the development of Swezey Newins and, ultimately, the chain of Swezey's Department stores that brought family-friendly shopping to communities across Long Island. The Swezey's stores were a mainstay in each community where they operated. In the early 1960s, Jerry Knapp was introduced to Warren Buffett by his brother Tom, and the trio formed a lifelong friendship. That friendship was the basis for establishing the family Foundations to begin their legacy. From that beginning, Priscilla Knapp developed and nurtured the vision that is followed today by the extended family. This vision is manifested through the generosity of Priscilla, Bill, Dave, and their collective family foundations: The Knapp Swezey Foundation, The Island Outreach Foundation, and The Gardener Foundation.

These leaders and their foundations have used their philanthropy to preserve, enhance and change the landscape of this Island we call home. Their generosity has impacted the Patchogue Family YMCA for

more than 20 years through operational support, funding of special projects, and more. When the vision of a new Patchogue Family YMCA was developed, the entire Knapp family stepped forward to make this dream a reality.

The Patchogue Family YMCA is truly the gateway to Patchogue. This highly recognizable, gleaming facility welcomes visitors to the neighborhood, serves the community in countless ways, and is an attraction that exemplifies community pride. It allows the YMCA to demonstrate the many ways it can serve and strengthen communities. The family has donated land, provided operational and capital funding and fostered volunteerism. Dave served as Co-Chair of the new facility campaign in Patchogue and serves as member of the Board of the Patchogue Family YMCA. The family has been a consistent presence at the Patchogue Y golf outing. Priscilla's involvement has brought valuable support and partnerships with other local causes and organizations, and Bill has been a loyal and true donor to each project of significance.

The YMCA of Long Island relies upon philanthropy to meet and grow its mission. The Knapp Family is an example of the leadership and generosity that has enabled the Y to flourish, and join Swezey's Department Stores, as an institution with a rich, 100-year history.

The Arlindo & Evelyn Jorge Family Foundation was founded in 2003 by Arlindo Jorge. His daughter, Judy Jorge, oversees the foundation along her close-knit family, including her brother Arlin, their children and nieces. Together as a family foundation, they continue to steer the strong philanthropic vision that was instilled by her parents. Her father taught his children about philanthropy through active participation in donating to causes that were personal to them. It was through this early hands-on approach that has guided three generations of the Jorge Family to support causes with a focus on community, education, and wellness.

Judy's history with the YMCA began as a young girl, where she and her siblings took swim lessons and attended summer day camp at the YMCA at Glen Cove. When Judy and her late sister moved to Huntington, their daughters participated in swim lessons, summer day camp, and preschool. Today, many family members use the Y in Huntington and Glen Cove. The Y continues to be a part of the Jorge Family through generations.

As Judy became more involved with the YMCA, she began to support programs and services that she was passionate about. It was learning about

LIVESTRONG® at the Y program for cancer survivors, who want to regain or maintain their health, which inspired Judy's further commitment and support.

She later joined the Huntington YMCA Steering Committee that spearheaded the Healthy Living Center Capital Campaign over several years. The 30,000 square-foot Huntington YMCA Jorge Family Healthy Living Center opened its doors on July 1, 2019. The state-of-the-art facility includes a 7,500 square-foot gymnasium, suspended indoor track, four group exercise studios, indoor cycle studio, basketball court, two volleyball courts, four Pickleball courts, STEM educational room, instructional kitchen, universal locker rooms, and offers more than 100 exercise classes each week in addition to recreational sports programs.

The Arlindo & Evelyn Jorge Family Foundation has generously supported the Huntington YMCA, Huntington Hospital on Long Island, the Adirondack Experience, The Museum on Blue Mountain Lake, and the Wild Center in Tupper Lake. The foundation has more than 15 years of creating positive change in their local communities.

Frank Boulton was born on Long Island and moved to the Bay Shore/Brightwaters area at the age of three. He graduated from Villanova University in 1973 with a BS in Finance. Mr. Boulton started a 25-year career on Wall Street in the U.S. Treasury and MBS bond industry. He retired from Smith Barney in 1994 as Senior Managing Director of the Government Bond Department but returned to Wall Street from 1996-1999 to serve as the Senior Executive Vice President in charge of the Fixed Income Department for Yamachi America.

Mr. Boulton presently serves on the YMCA of Long Island Board. He served as Chairman of the Great South Bay YMCA Board of Managers from 1983-1992, and was a Great South Bay YMCA board member for 27 years. He chaired the capital campaign, raising \$6.2 million to construct the YMCA. In 1992, the Board of Managers named the gymnasium in his honor.

The Boultons purchased the old Regent Theatre and donated it to the Great South Bay YMCA. The Boulton Center for the Performing Arts recently celebrated its 15th anniversary.

Currently, Mr. Boulton is in the 21st season as Founder and CEO of the Long Island Ducks, Baseball America's 2007 Organization of the Year.

Mr. Boulton is Chairman of the QuackerJack Foundation, the charitable arm of the Ducks. He is a member of the Suffolk Sports Hall of Fame, Bay Shore High School Hall of Fame, and Long Island Business Hall of Fame. He has been the recipient of multiple awards including, Long Island's 100 Most Influential People by LIBN, Entrepreneur of the Year by ACIT, The Harry Chapin Humanitarian of the Year by LIA, and the St. Thomas of Villanova Alumni Medal, awarded to individuals who have brought extraordinary benefit to Villanova University and their communities.

Mr. Boulton and his wife, Karen, currently live in Brightwaters. They are the proud parents of Whitney and Morgan.

PETER RETTALIATA

Mr. Rettaliata retired at the end of 2014 as the President and Chief Executive Officer of Air Industries Group, Inc. Pete currently serves on the Board of Directors of Air Industries Group, as a consultant to small aerospace firms, and has over 45 years of aerospace experience. He began his career at Grumman in 1973, eventually becoming the Company's Senior Procurement Officer. In that position, Mr. Rettaliata was responsible for all procurement activity for the corporation.

In 1994, he was a senior member of the transition team integrating the Northrop-Grumman combination. Following his tenure at Grumman, Mr. Rettaliata became a partner and the President of Air Industries Machining Corporation. He has led the company's growth from \$10mm in revenue in 1995 to nearly \$70mm in annualized revenue, and created Air Industries Group as a corporate entity aimed at substantial organic and acquisition growth.

Mr. Rettaliata is the former Chairman of "ADDAPT," an organization of regional aerospace companies. He is a former member of the Board of Governors' Executive Committee of the Aerospace Industries Association ("AIA"), and a member of the Executive Committee of

the AIA Supplier Council. He has served as the Chairman of the Great South Bay YMCA Board of Managers, Director of the Metropolitan YMCA Board of Directors, as a member of Southside Hospital Advisory Counsel, and was previously a member of the Seatuck Nature Center Board of Directors.

More recently, Mr. Rettaliata volunteered as a certified substance abuse counselor at YMCA Family Services. He subsequently helped to create and now serves as Chairman of the YMCA Family Services Board of Managers.

Mr. Rettaliata is a graduate of Niagara University and the Harvard Business School. He lives in Brightwaters with his wife Mary. Their children, Kate and Pete, live locally with their spouses Doug and Holly. Kate and Doug's three-year-old daughter, Elodie, is the absolute joy of their lives.

SCOTT SAMMIS

Andrew Sabin, Chairman of Sabin Metal Corporation and founder of Sabin Commodities, is one of America's most successful business leaders and noted environmental philanthropists.

His grandfather, Abraham Seratoff, immigrated to New York in the late 1800s and built a flourishing company that by the 1940s became known as Sabin Metal.

Not content to simply manage the family business he inherited, Andrew has overseen a major expansion and transformation of Sabin Metal. Today, the company recovers and refines precious metals from the hydrocarbon, petroleum/petrochemical, chemical, pharmaceutical, nitric acid, electronics, mining, and other industries that use precious metals in their products or processes. Sabin Metal Corporation is now the largest privately-held precious metal refiner in the world, serving not just the U.S. market, but also South America, Europe, Asia and Middle East.

Mr. Sabin has been actively engaged with community and environmental programs around the world. He founded the South Fork Natural History Museum in Bridgehampton, NY and continues to lead nature walks for the institution. Due to his global efforts, there are two frogs

named after him, *Centrolene sabine* (aka Sabin Glass Frog) and *Aphantophryne sabini*, one pigmy chameleon, *Rhampholeon sabini*, and a dwarf lemur, *Cheirogaleus andysbini*.

In 2007, Mr. Sabin established the Andrew Sabin Family Foundation. The foundation focuses on the environment, preservation of amphibian and reptile species and their habitat as well as funding cancer research at MD Anderson Cancer Center and genetic research at Memorial Sloan Kettering Cancer Center.

Recognizing the key role of education in these efforts, the Andrew Sabin Family Foundation funds the Sabin Center for Climate Change Law at Columbia University, the Emmet Institute on Climate Change & the Environment at UCLA School of Law, in addition to masters-level scholarships at Yale School of Forestry & Environmental Studies and the Sabin Sustainable Venture Prize at Yales' Center for Business and the Environment. The Foundation is also involved in habitat preservation through organizations such as Global Wildlife Conservation and the Turtle Conservancy.

His greatest ambition is to endow his four sons with a strong, responsible and growing family business and a safe and thriving planet for future generations.

The Sammis family roots reach back to a small clan living on the banks of the Thames River near London over 1,000 years ago. The clan was called "Thamesways", because it lived on the banks of that river. Over the years the name morphed into "Samways," "Samwise," and eventually Sammis.

John Sammis arrived in the New World on the ship "Hopewell" in 1654, moved west through the Williams Colony in Rhode Island, across Long Island Sound to the North Fork of Long Island, and settled ultimately in what would later become Lloyd Harbor in Huntington. He was a co-founder of the town, whose name was derived from Huntingdonshire in England. John and his sons and grandsons were leaders of their church and the town governing bodies for a century before the American Revolution. Oliver Smith Sammis founded the general store on the corner of Main Street and New York Avenue in the village of Huntington in 1849 which survived over the decades to become Sammis, Smith and Brush Insurance Agency. The family business grew to 52 employees by 2007 under the leadership of Scott Sammis and his father, Quentin.

Growing up in Huntington in the 50s and 60s, Scott and his sisters, Jane and Sue, quickly learned the family secret from their parents, Quentin and Ellie and grandfather Byron. The blessings the family had received over the generations came directly

from the tireless effort of "giving back" to the community.

The brand new town of Huntington welcomed immigrant John Sammis in the 1650s just as it welcomed Scott and his sisters in the 1950s and Scott's children Trevor, Becky, and John in the 1980s. Byron worked ceaselessly for Huntington Hospital as chief fundraiser and Board Chairman. Quentin served the Town as Supervisor and Councilman. Ellie worked for decades for the Family Service League and as a leader of the Old First Church. The kids and grandkids learned that community service is simply a part of the Sammis family fabric.

The Sammis family love affair with the Y started with Byron's efforts, as a member of the Rotary Club, to secure property for the new Huntington Y in the 50s, continued through Quentin's work to build the Norton Pool in the 60s, and progressed with Scott's help on the Albicocco Pool in the 1990s and the Sammis Family Child Care Center in 2010. Trevor, Becky, and John grew up in the Huntington Y, Becky has promoted the Y's new health programs, and John has served as a counselor in the **LIVESTRONG**® program.

Huntington and Long Island have been very generous to the Sammis family for 13 generations and they can't do enough to say 'Thank You' and give back.



Centennial Leadership Award

HEALTHY LIVING

ARMAND D'AMATO

Armand D'Amato began his career when he was elected to the New York Assembly, in 1972, and served with distinction until 1987. During his tenure, he was a member of the subcommittee of the handicap dealing with special needs children, including deafness. While serving on this committee, he found out his oldest daughter was born deaf. It was at that time, he became a board member of the Deafness Research Foundation, which is known today as the Hearing Health Foundation. He served as Chairman of the foundation for five years.

While serving in the Assembly, he joined the advisory board of the Hagedorn Little Village School, a school located in Nassau County that provides therapeutic programs to infants, pre-school, and elementary school children with a wide range of developmental delays. He eventually became a trustee and then chaired the board for five years. Today, Little Village is the premier school in Nassau County for children with special needs. Mr. D'Amato is one of two recipients of the HLVS Lifetime Achievement Award,

in recognition of his selfless devotion and lifeless endeavors on behalf of children and adults.

In 1975, Mr. D'Amato founded the law firm of D'Amato, Forchelli, Capetola which is known today as Forchelli, Deegan, Terrana. Presently, he serves as Managing Director at Park Strategies, LLC.

Mr. D'Amato has been a member of five YMCAs covering a span of fifty years, and currently sits on the corporate Board of Directors of the YMCA of Long Island. While a member of the Huntington YMCA Advisory Board, he chaired the Building Fund Drive for the expansion of the Sammis Family Child Care Center.

Mr. D'Amato earned his J.D. from Suffolk University Law School and an undergraduate business degree in accounting from St. John's University. Armand D'Amato resides in the hamlet of Oyster Bay, where he is a volunteer EMT for the Oyster Bay Fire Department One. He is the father of five children, and has one granddaughter.

SOCIAL RESPONSIBILITY

PETER J. MASTAGLIO

Peter J. Mastaglio has served as counsel to the YMCA of Long Island since 1974, has been a director since 1981, and served as Chairman of the Board from 1981 to 1984. Peter has also found time to serve as an officer or board member of the Epilepsy Foundation, the Garden City Family Life Center, and as District Chair of the New York Bar Foundation.

He began his legal career as a Judge Advocate and ultimately a Captain in the United States Marine Corps serving in Quantico, Virginia and the former Republic of Vietnam. ABC NEWS

N.J. Burkett joined the Eyewitness News team in 1989. His distinctive storytelling, production skills and award-winning international reporting have added a unique dimension to WABC-TV's coverage of metropolitan New York.

He has reported on everything from war and diplomacy to crime and politics; from aviation disasters to natural disasters, race relations and police misconduct.

On September 11, 2001, after the two jets struck the World Trade Center, N.J. and his photographer narrowly escaped the subsequent collapse of the South Tower. Their work was later seen on television news broadcasts across the nation and around the world and is on permanent exhibit at the Newseum in Washington, DC.

N.J. spent nearly three months covering the war in Iraq in 2003, and the military build-up that preceded it. He covered the terrorist bombings in Madrid (2004) and London (2005), as well as the war between Israel and Hezbollah in Southern Lebanon (2006), the Israeli-Hamas War in Gaza (2009-10) as well as three Israeli national elections and the death of Palestinian leader, Yasir Arafat (2004). N.J. witnessed the historic Israeli withdrawal from the Gaza Strip (2005) and chronicled the Palestinian popular uprising, known as the Intifadeh, in a series of overseas assignments from 2000-2004.

He was the only local New York television news correspondent to report from Japan after the historic 9.0 earthquake, tsunami and nuclear accident in 2011, and the first among his colleagues to report from Haiti after the earthquake there, in 2010.

In New York, N.J. has been one of WABC-TV's

lead reporters for many of the region's biggest stories, from Superstorm Sandy to the crash of TWA Flight 800, the massacre at Sandy Hook Elementary School and landmark police misconduct trials. When a growing number of homeless New Yorkers complained that the city's municipal shelters were unsafe, N.J. went undercover for several weeks in the winter of 2001, disguised as a homeless man. He and an undercover photographer slept in New York's most notorious men's shelter.

N. J.'s work has been honored with several of the most prestigious awards in American television news. He is a two-time winner of the coveted Edward R. Murrow Award from the Radio Television Digital News Association (formerly the RTNDA) and a four-time Emmy Award winner, including the Emmy for Outstanding On-Camera Achievement in 2003 and 2007. N.J. has received fifteen Emmy Nominations.

He shared the George Foster Peabody Award and the Alfred I. duPont-Columbia University Award with his colleagues at ABC News for his reporting on the September 11th terrorist attacks. In 2008, he was presented with the Allen B. DuMont Broadcaster of the Year Award by Montclair State University for his "significant contributions to the field of broadcasting."

N.J. is the First Vice Chairman of the National Academy of Television Arts & Sciences, and a former Trustee and past President of the Academy's flagship chapter in New York.

His full name is Newton Jones Burkett. Before joining WABC-TV, N. J. was a correspondent for WFSB-TV, the CBS station in Hartford, CT., from 1986-1989. He holds a B.A. in Political Science and a Master's in International Affairs, both from Columbia University.
