- 9. All participants must be properly dressed for all activities. For gym activities, shorts or sweats, T-shirts and sneakers should be worn.

It is understood that if I am not able to maintain these standards, my parent/guardian will be called, and I will be asked to leave the Pre-Teen Center and may not be invited to return.
