I do also hereby release all of those mentioned and any others acting upon their behalf from any responsibility or liability for any injury or damage to myself, including those caused by the negligent act or omission of any those mentioned or others, acting on their behalf or in any way arising out of or connected with my participation in any activities of the YMCA or the use of any equipment at the YMCA. RELEASE / LIABILITY WAIVER:

In consideration for being permitted to utilize the facilities, services and programs of the YMCA for any purpose, including but not limited to observation or use of facilities or equipment, or participation in any program affiliated with the YMCA, without respect to location, the undersigned, for himself or herself and any personal representatives, heirs and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that entry into the YMCA for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereon and such affiliated programs have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use, or participation.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER THE YMCA FOR ANY PURPOSE, INCLUDING BUT NOT LIMITED TO OBSERVATION OR USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANY PROGRAM AFFILIATED WITH THE YMCA, WITHOUT RESPECT TO LOCATION, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

- 1) THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the YMCA, its directors, officers, employees and agents (hereinafter referred to as "releasees") from all liability to the undersigned, his personal representatives, assigns, heirs and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein, or participating in any program affiliated with the YMCA, without respect to location.
- 2) THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in, upon, or about the YMCA premises or in any way observing or using any facilities or equipment of the YMCA or participating in any program affiliated with the YMCA whether caused by the negligence of the releasees or otherwise.
- 3) THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to negligence of releasees or otherwise while in, about, or upon the premises of the YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the YMCA, including but not limited to any virus or communicable disease exposure claimed.

THE UNDERSIGNED further expressly agrees that the forgoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of New York and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

YMCA OF LONG ISLAND PROGRAM CODE OF CONDUCT

The YMCA of Long Island is a community center where we value respect for people and property. We want to establish a safe and secure activity center where participants can interact positively with peers.

We are excited that you will be participating in this program. To ensure the safety and well-being of all individuals, we ask that you adhere to the following Code of Conduct. Please know that at any time, Program Supervisor can decide to remove a participant from the program for violating one of the items listed below.

1. Everyone must come to the program ready to have fun.
2. Demonstrate the YMCA Values of Respect, Responsibility, Caring, and Honesty.
3. Treat others the way you want to be treated. This includes staff members, volunteers and peers.
4. Respect the YMCA facility. Damage to YMCA property and/or equipment will not be tolerated.
5. Foul or abusive language, bullying, and fighting will not be tolerated.
6. Wearing hats and/or bandanas is prohibited.
7. Wandering around the building is prohibited.
8. Outside food and drinks (aside from water) is prohibited.
9. The YMCA is not responsible for any valuable lost or stolen. Participants are responsible for their own property. Electronics (cell phones, iPods, iPads, video games, etc.) are prohibited during program times, unless otherwise instructed.
10. Cigarettes, vapes, alcohol, drugs, and weapons are prohibited. Anyone suspected of having any of these items are subject to expulsion from the program.
11. Participants must be dressed properly for all activities. For gym activities, shorts, sweats, t-shirt and sneakers are required. For pool activities, if applicable, a swim suit is required.

It is understood that if I am not able to maintain these standards, my parent/guardian will be called, and I will be asked to leave the program and may not be invited to return.
